### 2. 2009 Recycling Tonnage Report Payouts:

- Joe Davis announced on July 21 that the payouts have been calculated and are awaiting final approval;
- Total pot of money ~ \$13 Million;
- Individual Essex payouts attached.

---

### 3. Finalized 2009 Recycling and Solid Waste Data:

- Final 2009 recycling and solid waste data compiled by NJDEP;
- Countywide MSW recycling rate for Essex County: 39.4% (2008: 39.8%);
- Statewide MSW recycling rate: 37.3%;
- Essex ranked 7<sup>th</sup> out of 21 counties.

---

### 4. Preliminary 2010 Recycling Rates (hand-out):

- Preliminary data shows a Countywide MSW recycling rate for Essex of 44.69% (note: missing tonnage data from Cedar Grove);
- Hand-out highlights MSW recycling rates for each municipality, including a rate without vegetative waste to better show the level of traditional material recycling (ie. commingled containers, fiber, metals).

---

### 5. Food Waste Recycling to Start in Salem County:

- Food waste to energy plant to be constructed to process approximately 500-tons per day;
- Solicitation of food waste in the local area has garnered over twice that amount as available feedstock;
- Waste to be digested, producing fuel for engines to create electricity to be sold on the open market;
- Solids left over used to create a compost material and sold on the open market;
- Breaking ground by October 1, 2011;
- Opportunity for Essex County to host a similar facility?
