- b. **Health Department Report** No report
- c. Covanta
 - i. Mr. Bernardino reported on the recent "Purple Plume". It was caused by large amount of Iodine in the waste. He explained that the plume was not hazardous, the DEP was aware of it. He also stated that the other Covanta facilities have experienced similar plumes. There was discussion by the members and Mr. Bernardino about the steps Covanta was taking to identify the source of the Iodine and the difficulties he was having. It was suggested by Mr. D'Altilio that he contact the Essex County Health Department or Essex Regional.
 - ii. Mrs. Parker commented on the programs and partnership that Covanta and the City of Newark have including Keep America Beautiful and the Ewaste event.
