MEETING OF THE ESSEX COUNTY SOLID WASTE ADVISORY COUNCIL. November 26, 2019 AT THE ESSEX COUNTY ENVIRONMENTAL CENTER, CLASSROOM, ROSELAND NEW JERSEY.

- 1. Call to Order 1:03 P.M. Meeting was called to order by Chairman Nick Salese, West Orange.

 - i. Minutes were Approved
- 5. Chairperson's Comments –Mr. Salese asked Mr. DeFeo to report on the status of 2 Bills S2776 is the plastic bill That Prohibits carryout bags made of plastic film, polystyrene foam food service products, and single-use plastic straws; assesses fee on paper carryout bags. It is anticipated that this Bill will pass in the Lame Duck Session and that the Governor will sign. There was additional discussion by the SWAC members as to the impact this Bill, if signed into Law, would have on existing Municipal Ordinances. Mr. DeFeo commented that the existing Municipal Ordinance must, at a minimum, comply with the State Law
- 6. S2815 is the paint bill "Paint Care" Requires paint producers to implement or participate in paint stewardship program. This is the Bill that needs support from SWAC Members and local government.
 - a. Mr. D'Altilio was tasked with forwarding copies of both Bills to the SWAC members and MRCs

Other towns reported that under the terms of their Recycling contracts the hauler is responsible for all disposition costs.

Mr. DeFeo also reported that 2 Million Tons of new domestic fiber processing facilities should come on=line in the next two years.
