RESOLUTION OF THE ESSEX COUNTY UTILITIES AUTHORITY AUTHORIZING PAYMENT OF BILLS FROM THE AUTHORITY'S SOLID WASTE OPERATING ACCOUNT AND WATER SYSTEM OPERATING ACCOUNTS

WHEREAS, in order to, among other things, provide for the provision of solid waste management services in a more effective and efficient manner, the Board of Chosen Freeholders of the County has, by ordinance finally adopted July 1, 1992 (the "Creation Ordinance"), created the Authority and empowered the Authority to provide (directly or by contract) for the collection, transportation, recycling and disposal of solid waste generated within the geographic boundaries of the County in an environmentally sound manner; and

WHEREAS, pursuant to the provisions of the Creation Ordinance, the County has designated the Authority as the agency responsible for implementation of the provisions of the County's Solid Waste Management Plan and the Water Supply and Distribution System; and

WHEREAS, pursuant to the provisions of the amendment to the Creation Ordinance, the County has authorized the Authority to undertake the provision and distribution of potable water for public and private uses for municipalities and commercial establishments (in addition to the County) located within the County; and

WHEREAS, in order to give effect to, and facilitate the transfer from the County to the Authority of responsibility for the development, administration and implementation of an integrated solid waste management system, as contemplated by the terms of the Creation Ordinance, the Board of Chosen Freeholders of the County by resolution duly adopted September 9, 1992, determined to assign and/or transfer to the Authority all agreements, documents and/or regulatory orders relating to solid waste matters; and

WHEREAS, in furtherance of such responsibility, the Authority has incurred certain costs and expenses relating to the development, administration and implementation of its solid waste system and water supply and distribution system and such costs and expenses constitute Operating Expenses.

WHEREAS, the Authority desires to approve such invoices for payment; now therefore,

BE IT RESOLVED BY THE ESSEX COUNTY UTILITIES AUTHORITY, as follows:

Section 1. (a) The invoices submitted to the Authority for services rendered are set forth on Exhibit A which is attached hereto and which by this reference is made part hereof as if set forth in full herein. Such invoices are hereby approved.

(b) Such invoices shall be paid by the Authority from amounts which are on deposit in the Authority's Operating and Bond Accounts and Water System Project Note Accounts, established and created pursuant to the Authority's resolutions.

Section 2. This resolution shall take effect immediately.

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

RESOLUTION OF THE ESSEX COUNTY UTILITIES AUTHORITY AUTHORIZING THE EXECUTION AND FILING OF AN APPLICATION WITH RESPECT TO A 2024 RECYCLING ENHANCEMENT ACT TAX FUND GRANT

WHEREAS, in order to, among other things, provide for the provision of solid waste management services in a more effective and efficient manner, The Essex County Utilities Authority (the "Authority") has heretofore been created by ordinance of the County of Essex, New Jersey (the "County"), finally adopted on July 1, 1992, pursuant to and in accordance with the provisions of the Act, as a public body corporate and politic, with all necessary and proper powers to acquire, construct, maintain, and operate or contract for the operation of facilities for the collection, transportation, processing, recycling and disposal of solid waste generated within the geographic boundaries of the Essex County Solid Waste Management District in an environmentally sound manner; and

WHEREAS, by resolution duly adopted September 9, 1992, the Essex County Board of Chosen Freeholders assigned to the Authority its right, title and interest in all agreements, documents and/or regulatory orders previously executed by the County or relating to the Essex County Solid Waste Management District with respect to solid waste management, including but not limited to, the grant moneys received or to be received by the County from the State of New Jersey; and

WHEREAS, the County and the Authority entered into the Amended and Restated Agreement of Assignment, dated as of July 2, 1993, in order to effectuate the terms of the resolution adopted by the County on September 9, 1992 with respect to the assignment of solid waste activities and responsibility to the Authority; and

WHEREAS, on August 4, 1993, the Essex County Board of Chosen Freeholders adopted an amendment to the Essex County District Solid Waste Management Plan that designates the Authority as the implementing agency of the Plan as provided by the Act, which amendment was filed with the Department of Environmental Protection ("DEP") for certification and approved in accordance with the Act; and

WHEREAS, P.L. 2007c.311 provides for the disbursement of moneys from the Recycling Enhancement Act Tax Fund by the Commissioner of the DEP to

Counties for the purpose of preparing, revising and implementing solid waste management plans; and

WHEREAS, the Authority, as assignee of the rights of the County to receive such moneys, desires to execute and file an application for the receipt of a 2024 Recycling Enhancement Act Tax Fund Grant; now therefore,

BE IT RESOLVED BY THE ESSEX COUNTY UTILITIES AUTHORITY, as follows:

Section 1. Application is hereby authorized to be made to the Commissioner of the DEP for a disbursement from the Recycling Enhancement Act Tax Fund in the amount of \$615,600.00

Section 2. The Solid Waste and Recycling Coordinator of the Authority is hereby authorized and directed to (a) execute and file an application with the Commissioner of the DEP with respect to such grant, (b) execute any contracts evidencing such grant, and (c) act as the authorized representative of the Essex County Solid Waste Management District. The Authority's staff is authorized to provide additional information and to furnish such documentation as may be required by the DEP to act upon such application.

Section 3. The Authority does hereby hold the State of New Jersey, and its departments and agencies, harmless for any damages, losses and claims, which may arise directly or indirectly from the execution of the grant application and disbursement of the grant proceeds.

Section 4. The Authority hereby accepts the terms and conditions set forth in the Solid Waste Management Act and the regulations promulgated under it.

Section 5. This Resolution shall take effect immediately.

RESOLUTION OF THE ESSEX COUNTY UTILITIES AUTHORITY AUTHORIZING CLOSED WORK SESSION FROM WHICH THE PUBLIC IS EXCLUDED

WHEREAS, The Essex County Utilities Authority (the "Authority") has been duly created and is validly existing as a public body corporate and politic of the State of New Jersey under the Municipal and County Utilities Authorities Law, constituting Chapter 183 of the Pamphlet Laws of 1957, of the State of New Jersey and the acts amendatory thereof and supplemental thereto; and

WHEREAS, the Authority constitutes a "public body" as such term is defined in the New Jersey Open Public Meetings Act, constituting Chapter 231 of the Pamphlet Laws of 1975 of the State of New Jersey and the acts amendatory thereof and supplemental thereto (the "Open Public Meetings Act"); and

WHEREAS, the Open Public Meetings Act permits a "public body", as such term is defined therein, to exclude members of the public from portions of any "meeting", as such term is defined therein, under certain limited circumstances, including (a) any discussion of pending or anticipated litigation in which the public body is or may become a party, or (b) any matters which fall within the attorney-client privilege, as set forth in Section 7(b) (7) of the Open Public Meetings Act; and

WHEREAS, in order to enable the Authority to hold discussions concerning pending and anticipated litigation, the Authority desires to conduct a portion of the meeting in a closed work session from which members of the public shall be excluded; now therefore,

BE IT RESOLVED BY THE ESSEX COUNTY UTILITIES AUTHORITY, as follows:

Section 1. In accordance with the provisions of Section 8 of the Open Public Meetings Act, the Authority hereby determines to conduct a portion of the meeting in a closed work session from which members of the public shall be excluded in accordance with the provisions of Section 7 (b) (7) of the Open Public Meetings Act. Such closed work session shall be limited to matters relating to pending and anticipated litigation involving or expected to involve the Authority and matters which fall within the attorney-client privilege.

Section 2. Minutes of each closed work session shall be prepared and maintained by the Authority and such minutes shall be made available to members of the public at such time as the litigation to be discussed has been completed and/or the events giving rise to the privileged communications between the Authority and its counsel have ceased.

Section 3. This resolution shall take effect immediately.
